Judge Norman:

This report is submitted pursuant to O.S.S. 982a Title 22, Judicial Review, which provides for a twenty-four month Judicial Review for consideration of sentence modification. Jones meets the requirement. On September 15, 2017, Jones was present in Muskogee County District Court with attorney, Eric Jones and the state was represented by District Attorney, Orvil Loge. Jones entered her plea of no contest and was sentenced to twenty years' incarceration on felony case CF 2016-34 Cts. I & II. Both counts are to run concurrently to each other. **A Judicial Review hearing has been scheduled for September 13, 2018 at 1:30 p.m. in Muskogee County before Judge Norman.**

According to On Demand Court Records (ODCR), no other felony or misdemeanor charges were reported.

Jones arrived at the Mable Bassett Assessment and Reception Center (MBARC) in McLoud, Oklahoma on September 21, 2017. While being housed at MBARC, Jones was given a Level of Service Inventory-Revised (LSI-R) Assessment. Her score was thirteen which placed her in the low risk category to re-offend.

On September 28, 2017, Jones was transferred to the medium security Mabel Basset Correctional Center (MBCC) in McLoud, Oklahoma. She was not recommended for any institutional programs to date. Jones began working with the Guarding Angel Dog Program at MBCC March 1, 2018 and completed the Victim Impact class March 2, 2018. Attached is a copy of a certificate of completion of the 16 hour Partners In Parenting class.

As of the date of this writing, Jones has no institutional misconducts on record and was placed on earned credit level IV as of August 1, 2018 for privileges only. As of August 29, 2018, Jones had approximately 6,953 days left to serve on her sentence. She is eligible for parole in October 2034.

Upon release from incarceration Jones plans to reside with her parents, Kelli and Rodney Jones at 2401 W. Omaha at Battle Creek Apartments #214 in Broken Arrow, Oklahoma 74012; mother's cellular telephone number (918) 351-8040 and father's cellular telephone number (918) 271-2157. This reporting officer called and spoke with Mrs. Kelli Jones August 29, 2018 and verified the home offer. Mrs. Jones also stated the defendant will work with her father, Rodney Jones upon her release from incarceration at the family business, Splice Line Cable in Broken Arrow, Oklahoma.


If granted probation, the following Community Supervision Plan is recommended:

- Obtain a comprehensive evaluation for substance abuse needs and follow the prescribed treatment plan
- Have no contact with the victim
- Obtain gainful employment
- Pay all court ordered fines, fees and restitution

It is respectfully recommended modification of the defendant's sentence be determined by the court. She is not eligible for community sentencing placement.


